Market Outlook and Investment

With the steady improvement of US economy as well as the increasing core CPI, US Fed turned more hawkish upon the monetary policy. After US Fed's interest hike in March, investors now also expect further two or three interest hikes within year 2017. We believe that US government's initiatives on infrastructure and national defense shall help to propel US economy on the steady growth road. We expect that USD will remain relatively strong, but the commodity prices will be more volatile.

China's latest PMI figure was also rather strong at 51.8, which was still on the steady recovery path. Accompanying with the increasing materials prices, we also witnessed steady recovery of domestic demands. The central government stressed the financial stability will be the most important task for this year, and PBOC will enforce policies on de-leveraging and financial regulation. We expect neutral or actually tightening monetary policies for year 2017. But China's solid economic recovery shall be strong enough to tolerate the short term pain of de-leveraging.

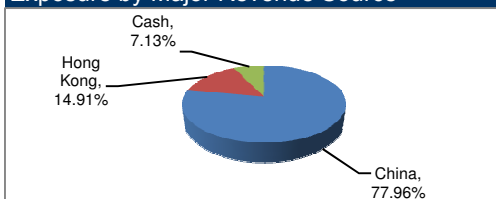

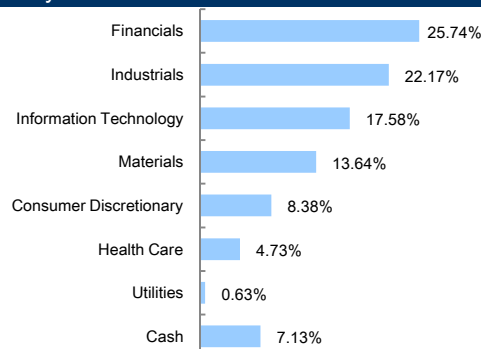
