## Market Outlook and Investment

The Core CPI in US is still on the up-trend track and the US macro figures also indicated strong economic growth. The market now expects another interest hike in June. The tax reform initiated by President Trump could boost the consumer confidence by significantly cutting the tax burden of US corporations and individuals. USD remains relatively strong, but the commodity prices tumbled.

China's latest PMI declined to 51.2 in April, which was much weaker than expected. As China's authorities intensify the squeeze on shadow banking, China's credit growth decelerated. The theme of reflation seemed not valid anymore, signaled by the sharp correction of commodity prices. But we still expect that China's solid economic recovery shall be strong enough to tolerate the short term pain of deleveraging; mainly due to the still expanding fiscal stimulus on FAI and OBOR projects.

In regard to our investment strategy, our tone turned relatively cautious on China / Hong Kong's market. The money supply turned more stringent in domestic China due to the continuing deleveraging; the market also lacks of stimulus after the annual result season. We will technically tilt in the domestic consumption sector; in order to catch the opportunity on sustainable growth of the sector.

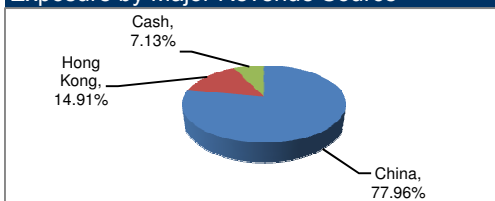

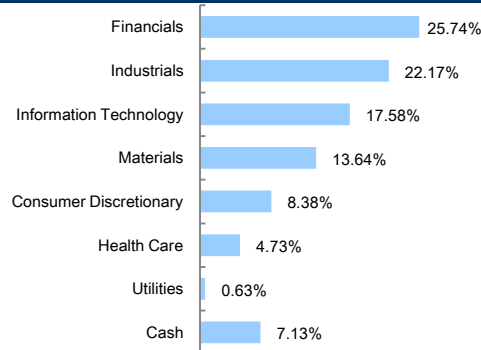
