

US stock market's sentiment stabilized though the concern on the outbreak of novel corona virus shadowed the global economic growth, with Dow Jones closed down by 0.99%, while S&P 500 was down by 0.16%, and Nasdaq has increased by 1.99%. The U.S. macro economy reported mixed data, the ISM Manufacturing Index of January jumped to 50.9 from 47.8 in December, beating market forecasts of 48.5. Looking forward to 2020, market sentiment has been boosted by tentative signs that manufacturing activity and global trade are bottoming out, a broad-based shift toward accommodative monetary policy, intermittent favorable news on US-China trade negotiations, and diminished fears of a no-deal Brexit. However, few signs of turning points are yet visible in global macroeconomic data.

As for China, the official manufacturing PMI in January was 50, which dropped from previous 50.2 but still remained at expansion area, while the Caixin PMI also reported strong data at 51.1. Export growth recorded 7.6% from previous -1.3%. CPI remained at high level at 4.5% in December, missing the consensus of 4.7%, mainly due to a surge in prices of food as the outbreak of African swine fever sent the price of pork soaring. As for the stock market, the CSI300 decreased by 2.26% to 4003.9, due to the concern on the corona virus which has already killed more than 300 people and get over 20,000 people infected.

In regard to our investment strategy for Hong Kong/China market, as the prospects of trade war is less cloudy due to the phase one deal has been reached, we tend to be more optimistic on the market of 2020. However, the corona virus did worth some attention, as it has led to the shutdown of several important cities and provinces. Although the protest movements in Hong Kong seemed quiet down in the past month, we believe the political dilemma has no short term solution, and local names would continue to be under pressure. Domestic leading sectors, such as consumer discretionary, have been relatively weak, as the actions to stop the

virus spreading, such as traffic control and quarantine, would hurt those companies' 1Q results, though we view the situation would hopefully end in 2Q.
