
The Sub-Fund seeks to achieve its investment objective by investing primarily (i.e. not less than 70% of its NAV) in USD-denominated short-term deposits and high quality money market instruments issued by governments, quasigovernments, international organisations, financial institutions and corporations. The Sub-Fund may invest up to 30% of its NAV in non USD denominated short-term deposits and high quality money market instruments.
