





Market Outlook and Investment Strategy

The outlook of the oversea markets remained rather dim, as Spain became the next possible candidate for insolvency. US' recovery was sluggish as well, as its employment and housing market showed little sign of picking-up. The hope of US Fed's further monetary easing turned to be vain again. We hardly see any positive catalysts in short term.

The economic situation in China is disappointing as well. 2Q recorded the slowest GDP growth in the past 18 months. Export growth and industrial production growth further slowed down. We now expect that the concrete economic recovery may be postponed till the end of the 3Q, as the effects of the government's stimulus policies are yet to see.

Investment opportunities are likely to exist in following areas for the next month: FAI stimulus related sectors, banks and Energy-saving and environmental
