

Market Outlook and Investment Strategy

The latest US economy data was mixed but generally on the positive territory. As the US housing market kept recovering, market started to worry about the risk of the early exit of the QE plan. The recent turmoil in Cyprus again led to investors' serious concern on the endless troublesome Euro Zone credit crisis issue.

There was not much surprise on the policies after China's "two sessions". The economic target set for this year is achievable and reasonable. Hong Kong market was stroke by the fear of eruption of bird flu which we believe is unlikely; while the fundamental theme of China's recovery is intact in longer term. We recommend investors staying cautious and playing with leading players with solid fundamentals
